On September 22, 2015, BlackRock Financial Management, Inc., Wilmington, DE, United States has informed us according to Article 21, Section 1 of the WpHG that via shares its Voting Rights on adidas AG, Herzogenaurach, Germany, have exceeded the 5% threshold of the Voting Rights on September 18, 2015 and on that day amounted to 5.01% (this corresponds to 10475843 Voting Rights).

2.30% of Voting Rights (this corresponds to 4812224 Voting Rights) are attributed to the company in accordance with Article 22, Section 1, Sentence 1, No. 1 of the WpHG (German Securities Trading Act).

0.02% of Voting Rights (this corresponds to 37684 Voting Rights) are attributed to the company in accordance with Article 22, Section 1, Sentence 1, No. 6 of the WpHG (German Securities Trading Act).

2.99% of Voting Rights (this corresponds to 6265357 Voting Rights) are attributed to the company in accordance with Article 22, Section 1, Sentence 1, No. 6 in connection with sentence 2 of the WpHG (German Securities Trading Act).
